A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, VACATING INGRESS AND EGRESS EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 24050, PAGE 803 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, ALSO BEING A PORTION OF LOT 5, BLOCK 46, "TOWN OF LAUDERDALE", ACCORDING THE PLAT TO THEREOF, AS RECORDED IN PLAT BOOK "B", PAGE 40, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA, LOCATED WEST OF SOUTH ANDREWS AVENUE, NORTH OF SOUTHWEST 6TH STREET, EAST OF SOUTHWEST 1ST AVENUE AND SOUTH OF SOUTHWEST 5TH STREET, ALL SAID LANDS BEING IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, under the provisions of Section 47-24.7 of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR"), OCITA Properties, is applying for the vacation of a 24-foot by 159-foot access easement (Case No. E18008) more fully described in Section 1 below, associated with the development known as Riverparc Square, located at 501 South Andrews Avenue, Fort Lauderdale, Florida; and

WHEREAS, pursuant to the provisions of the aforementioned Section 47-24.7 of the ULDR, all utilities known to have an interest have been notified and have no objection to the vacation of the easement; and

WHEREAS, the City Engineer has certified that there is no objection to the vacation; and

WHEREAS, the Department of Sustainable Development has made the required reports and has also recommended the vacation of the easement, certifying that the same will not be required to serve the property;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the below described easement is hereby vacated and shall no longer constitute an easement for ingress and egress, subject to the conditions provided in <u>SECTION 2</u> of this resolution:

A PORTION OF LOT 5, BLOCK 46, "TOWN OF FORT LAUDERDALE", ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK "B", PAGE 40, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA

More particularly described in Exhibit "A" attached.

Location: West of South Andrews Avenue, north of Southwest 6<sup>th</sup> Street, east of Southwest 1<sup>st</sup> Avenue and south of Southwest 5<sup>th</sup> Street.

<u>SECTION 2</u>. That the vacation of the easement shall not be effective until the applicant demonstrates compliance with the following conditions:

- 1. Any City infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and the relocated facilities shall be required to be inspected and accepted by the City's Public Works Department.
- 2. Any other utility infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and the relocated facilities shall be required to be inspected and accepted by the applicable utility agency or service provider.
- <u>SECTION 3</u>. That a copy of this Resolution shall be recorded in the Public Records of Broward County within 30 days from the date of final passage.
- <u>SECTION 4</u>. Issuance of a development permit by a municipality does not in any way create any right on the part of an applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the municipality for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.


