WHEREAS, SBBC and CITY desire to enter into this Informal First Amendment to Reciprocal Use Agreement to memorialize the amendment of **Exhibit A** to the Agreement to include one additional facility.

NOW, THEREFORE, in consideration of the mutual terms and conditions, promises, covenants, and payments, hereinafter set forth, SBBC and CITY hereby agree as follows:

- 1. Each and every WHEREAS clause set forth above is a true and correct recital and representation, and is incorporated herein as if set forth in full.
- 2. **Exhibit A** to the Agreement shall be amended to include South Side Cultural Arts Center. *A copy of the First Amended Exhibit A* is attached and incorporated as First Amended **Exhibit A**.
- 3. All other provisions of the Agreement shall remain in full force and effect.


