Chair Trantalis recognized Don Morris, Economic and Beach Redevelopment Area Manager of the Beach Area Community Redevelopment Agency. Mr. Morris confirmed the addition of property acquisition for incentive dollars for both commercial and residential property and would depend upon the project.

Resolution to Transfer Funding from the Bahia Mar Yachting Center Dredging Phase II Project in the Amount of \$567,105

Chair Trantalis recognized Don Morris, Economic and Beach Redevelopment Area Manager of the Beach Area Community Redevelopment Agency. Chair Trantalis commented on discussions with The Boat Show regarding dredging. Further discussions ensued on the amount of matching funds and who would provide them.

Mr. Morris, confirmed the CRA's contribution covers the area from the Intracoastal to the beach property line of Bahia Mar. Bahia Mar would cover matching funds for dredging from that property line to the dock. Executive Director Feldman commented on discussions with the consultant for this item, Tyler Chappell, regarding boat access.
