A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, VACATING PORTION OF THE RETAINED 10 FOOT UTILITY EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 10545, PAGE 941 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA. LYING NORTH OF THE SOUTH 3.47 FEET OF LOTS 30 AND 31, "EVA A. OLIVER'S SUBDIVISION OF BLOCK 28", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 1, PAGE 37, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA. LOCATED WEST OF SOUTHEAST 3 AVENUE, NORTH OF EAST LAS OLAS BOULEVARD, EAST OF SOUTHEAST 2 AVENUE AND SOUTH OF SOUTHEAST 2 STREET, ALL LOCATED IN THE CITY OF **FORT** LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, under the provisions of Section 47-24.7 of the City of Fort Lauderdale, Florida Unified Land Development Regulations (hereinafter "ULDR"), 212 Partners, LLC, submitted an application for the vacation of a 10-foot retained utility easement (Case No. E18009) more fully described in Section 1 below, located at 220 Southeast 2nd Street, Fort Lauderdale, Florida; and

WHEREAS, pursuant to the provisions of the aforementioned Section 47-24.7 of the ULDR, all utilities known to have an interest have been notified and have no objection to the vacation of the easement; and

WHEREAS, the City Engineer has certified that there is no objection to the vacation; and

WHEREAS, the Department of Sustainable Development has made the required reports and has also recommended the vacation of the easement, certifying that the same will not be required to serve the property;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the below described easement is hereby vacated and shall no longer constitute an easement for utilities, subject to the conditions provided in <u>SECTION 2</u> of this resolution:

THAT PORTION OF THE RETAINED 10 FOOT UTILITY EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 10545, PAGE 941 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA. LYING NORTH OF THE SOUTH 3.47 FEET OF LOTS 30 AND 31, "EVA A. OLIVER'S SUBDIVISION OF BLOCK 28", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 1, PAGE 37, OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA

More particularly described in Exhibit "A" attached.

Location: West of Southeast 3rd Avenue, North of East Las Olas Boulevard, East of Southeast 2nd Avenue and South of Southeast 2nd Street.

<u>SECTION 2</u>. That the vacation of the easement shall not be effective until the applicant demonstrates compliance with the following conditions:

- 1. Any City infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and the relocated facilities shall be required to be inspected and accepted by the City's Public Works Department.
- 2. Any other utility infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and the relocated facilities shall be required to be inspected and accepted by the applicable utility agency or service provider.

<u>SECTION 3</u>. That a copy of this Resolution shall be recorded in the Public Records of Broward County within 30 days from the date of final passage.

<u>SECTION 4</u>. Issuance of a development permit by a municipality does not in any way create any right on the part of an applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the municipality for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.
