

RESOLUTION NO. 18-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE FINAL BUDGET AND PERSONNEL COMPLEMENT OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017, AND ENDING SEPTEMBER 30, 2018, AS AMENDED, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #18-0844, AMENDING THE FINAL COMMUNITY INVESTMENT PLAN FOR THE FISCAL YEARS BEGINNING OCTOBER 1, 2017, AND ENDING SEPTEMBER 30, 2022, BY ABANDONING THE NEW RIVER SEAWALL, SEVEN ISLES SEAWALL IMPROVEMENTS, SEAWALL REPLACEMENT HIMMARSHEE CANAL NORTH, CITY OWNED SEAWALL REPLACEMENTS, AQUATIC CENTER SEAWALL, BAYVIEW DRIVE SEAWALL, 2731 FEDERAL HWY SEAWALL, LIDO DRIVE SEAWALL, AND MOLA AVENUE SEAWALL PROJECTS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution Nos. 17-200 and 17-202, adopted on September 13, 2017, the City Commission of the City of Fort Lauderdale, Florida, adopted the Final Budget and Staffing Levels of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2017, and ending September 30, 2018, and the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Years beginning October 1, 2017, and ending September 30, 2022;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Final Budget and Personnel Complement of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2017, and ending September 30, 2018, as amended, and the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Years beginning October 1, 2017, and ending September 30, 2022, to the extent appropriated for the Fiscal Year beginning October 1, 2017, and ending September 30, 2018, are hereby amended by appropriating funds as set forth in Commission Agenda Memo #18-0844, a copy of which is attached hereto and incorporated herein.

SECTION 2. That the New River Seawall, Seven Isles Seawall Improvements, Seawall Replacement Himmarshee Canal North, City Owned Seawall Replacements, Aquatic Center Seawall, Bayview Drive Seawall, 2731 Federal Hwy Seawall, Lido Drive Seawall, and Mola Avenue Seawall projects, contained in the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Years beginning October 1, 2017, and ending September 30, 2022, is hereby abandoned.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.
