TITLE: Ordinance to Establish and Revise Procedures for Redressing

Continuing, Repetitive, or Chronic Violations of the Code of Ordinances

and Revising Civil Penalties

#### Recommendation

It is recommended that the City Commission adopt an ordinance amending Article IV – Citation Violation Notice Procedures of Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale

#### **Background**

At the November 21, 2017 City Commission Conference Meeting, the need for a more aggressive approach to enforcement of chronic violations, a recommendation to establish criteria for defining chronic violations, and the desire for a process that is faster than special magistrate was discussed. During the discussion, the City Manager discussed the issuance of civil citations to address chronic violations in an expeditious manner (Exhibit 1).

Staff is recommending an amendment to Article IV. – Citation Violation Notice Procedures of Chapter 11 of the Code of Ordinances of the City of Fort Lauderdale to establish criteria for defining chronic violations, provide a method for the daily accrual of civil citations when there is a violation, and establish a mandatory hearing for chronic violations that affect the life, safety, and welfare of the community (Exhibit 2). If adopted, the Community Enhancement and Compliance Division will use civil citations as a resource for expeditious code enforcement of chronic violations.

The following summarizes the proposed ordinance amendments:

- Define chronic violation as three violations of the same code section within a sixmonth period by the same violator or same property owner.
- Provide a method for the daily accrual of civil penalties when a violation continues beyond the timeframe provided for correction.

- Establish a method for an alleged violator to request an appeal before the special magistrate and provide the manner by which the special magistrate shall make a determination when there is an appeal.
- Establish a mandatory hearing with a maximum penalty of \$500.00 per day for chronic violations of code sections related to the life, safety, and welfare of the community as outlined in the table of violations that a civil penalty may be issued for
- Increase the civil penalty for the following types of violations related to the life, safety, and welfare of the community.
