TITLE:	Motion to Approve Annual Contract for Asphalt Milling and Resurfacing Services - Weekley Asphalt Paving, Inc \$950,000 (two-year total)

#### **Recommendation**

It is recommended that the City Commission approve an annual contract, in substantially the form attached, to Weekley Asphalt Paving, Inc. (Weekley) for the asphalt milling and resurfacing services project in the estimated amount of \$950,000 (two-year total); and authorize the City Manager to approve two, one-year renewal options contingent upon appropriation of funds.

#### **Background**

This two-year contract is for the City's Annual Asphalt Milling and Resurfacing Services Project with work to be performed on a task order basis. The contract is separate from the new Road Services Team that is currently tasked with completing smaller patching projects. Work will include, but is not limited to, installation of Type S-3 asphalt concrete, Florida Department of Transportation Superpave 9.5 asphaltic concrete, thermoplastic pavement marking, milling and leveling of existing asphalt pavement, accessible concrete ramps, and other items quantified in the contract. In addition, the work may include surfacing newly constructed rock base and the resurfacing of existing pavement.

The intent of this contract is to mill and resurface roadways with pavement condition index below 55, as identified in the City's 2013 inspection by Atkins North America, Inc. This contract will also be utilized to construct improvements in or adjacent to City facilities and for other projects requiring the unit bid items included in the contract. The contractor has extensive experience with resurfacing projects throughout the City.

Invitation to Bid No. 12132-283 was issued on May 7, 2018. The bid opening was held on June 5, 2018 and three bids were received. The low bidder, Weekley, has met all of the specifications of the bid and has been deemed as a responsive and responsible bidder.

The bid requested line item unit pricings with indefinite quantities. Actual costs will be assessed by either task order or work order for each individual scope of work. This contract is developed to be a resource for any project, as it relates to asphalt milling and resurfacing work throughout the City.

# Resource Impact

There will be a current fiscal year impact to the City in the amount of \$60,000. Funds are available in the FY 18 budget in the accounts listed below. Future year expenditures are contingent upon approval of those respective budgets.
