TITLE:	Motion to Accept FY2018 Justice Assistance Grant – Emergency Fund – Overtime for February 14, 2018 Incident Response - \$9,420

## **Recommendation**

It is recommended that the City Commission approve the acceptance of grant funds in the amount of \$9,420 from the 2018 Justice Assistance Grant – Emergency Grant Program on behalf of the City of Fort Lauderdale.

## **Background**

On February 14, 2018, the City of Parkland experienced a mass-shooting incident at Marjory Stoneman Douglas High School (MSD). This incident resulted in the death and injury of several students and school staff members. The magnitude and urgency of the event resulted in a coordinated response from local, state and federal law enforcement and first responder personnel from more than 18 agencies. The deployment of law enforcement resources to manage this event diverted significant available resources and strained public safety services as well as budget capacities.

The Florida Department of Law Enforcement has approved this grant award under the Florida Justice Assistance Grant Emergency Fund. The grant award will reimburse the Fort Lauderdale Police Department for overtime costs associated with the response of its personnel to this incident.

### Resource Impact

There is a positive fiscal impact to the City in the amount of \$9,420. This grant does not require matching funds. Funds are being appropriated via Commission Agenda Memo 18-0844.
