#### Recommendation

It is recommended that the City Commission approve the purchase of the required licenses for the deployment of the Enterprise Content Management System (Laserfiche) for the Finance Department, including Utility Billing, from MCCI, LLC in the total amount of \$32,832.

## **Background**

On February 17, 2015, the City Commission approved the contract for purchase of Laserfiche from MCCI, LLC including funding for the initial task order for the deployment of the software and migration of electronic documents for the Department of Sustainable Development (DSD) (CAM #15-0251). The intention was to expand the use of the Laserfiche system organization-wide as the DSD project progressed in order to replace the City's outdated and unsupported electronic document management system which dated back to 2001.

On July 7, 2015, the City Commission approved additional purchases of hardware and software for Information Technology Services to build the server environment for Laserfiche (CAM #15-0806). On August 22, 2017, the City Commission approved the purchase of Laserfiche software licenses for the Human Resources Department (CAM #17-0932). Most recently, on October 17, 2017, the City Commission approved additional software licenses for Fire-Rescue and the City Clerk's Office (CAM #17-1148).

In order to continue the migration into Laserfiche, licenses for the Finance Department and Utility Billing Office are needed.
