TITLE: Motion to Approve an Amended One-Year Agreement with the School

Board of Broward County, Florida for School Resource Officer Program

Recommendation

It is recommended that the City Commission authorize the Mayor and City Manager to execute an amended one-year agreement with the School Board of Broward County (SBBC), Florida for the School Resource Officer Program commencing August 8, 2018 and concluding on June 5, 2019.

Background

On July 10, 2018, the City Commission approved an Agreement between the City and SBBC to place eight (8) School Resource Officers (SROs) at seven secondary schools operated by the SBBC. SROs will be placed on a full-time basis on the campuses of New River Middle, Sunrise Middle, William Dandy Middle, Dillard High, Fort Lauderdale High, Stranahan High and Whiddon Rogers. The Agreement as previously approved by the City Commission required the SROs to be present on the listed school grounds during "regular school hours", which was defined as, "Beginning when students arrive at the school to begin the school day and ends when the last school bus leaves the school." The SBBC has requested that the Agreement be amended to require SROs to also be present on teacher planning days. It should be noted that no additional subsidy will be provided by the SBBC for the SROs presence during this additional time.

Resource Impact

There will be a current fiscal year impact to the City. The cost is included in the FY 2018 operating budget in the accounts listed below. Future expenditures are contingent upon approval and appropriation of the annual budget.
