TITLE: Motion Approving 2019 Event Dates of the Agreement with Beach Majors

USA, LLC for Fort Lauderdale Major 2019 to be held on Fort Lauderdale

Beach, February 5 – February 10, 2019

Recommendation

It is recommended that the City Commission approve a motion for 2019 Event Dates of the Agreement with Beach Majors USA, LLC for Fort Lauderdale Major 2019 to be held on Fort Lauderdale Beach.

Background

The FIVB, the international governing body for the Olympic sport of beach volleyball, held the inaugural SWATCH FIVB Volleyball Season Final from September 29, 2015 through October 4, 2015.

At the November 15, 2016 Commission meeting, a five year agreement was approved by Commission. The event organizer submitted the attached Letter of Intent to host Fort Lauderdale Majors 2019 from Tuesday, February 5, 2019 – Saturday, February 10, 2019. The event organizer has notified staff of their intentions to host night games and or live band performances during event dates ending at 11:30 pm (Tuesday, February 5, 2019 – Saturday, February 10, 2019).

Effective October 1, 2015 the City began to enforce the noise requirements outlined in Exhibit 3. The event organizer has requested a special exemption to allow amplified music for this event until 11:30pm. The 2019 schedule of events is attached as Exhibit 8.

City staff has been working closely with the event organizer regarding event topics, such as logistics, maintenance, and security. The Police Department recommends approval of the closing of City streets where appropriate and event parking has been satisfactorily arranged. When applicable, amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of

insurance. The City is requesting the organizer to post an amount in escrow equal to 110% of the City's estimated service costs. In addition, the City is charging an administrative fee of 10% of the actual City Service costs. The organizer will also secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding events in their areas. Specific event details are included below:

In addition, the 12 volleyball courts in Fort Lauderdale Beach Park will be re-installed to the north of the event site so there is no disruption in the opportunity for the public to play volleyball on the beach during the event dates.

This year, the Fort Lauderdale Major 2019 overlaps with the 2019 Fort Lauderdale A1A Marathon/Half Marathon event. A Mutual Agreement is attached (Exhibit 5) for use of Fort Lauderdale Beach Park and the South Beach Parking Lot from January 17, 2019 through February 21, 2019.
