## **RESOLUTION NO. 18-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, WAIVING THE PROVISIONS OF DIVISION 2, PURCHASING, OF CHAPTER 2, ARTICLE V OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING COMPETITIVE BIDDING, COMPETITIVE QUOTES, AND PURCHASING THRESHOLD AMOUNTS, FOR THE PURCHASE OF OFFICE FURNITURE FROM PARADOX HOME STUDIO FOR THE CITY OF FORT LAUDERDALE MAYOR'S OFFICE.

WHEREAS, Section 2-176, Code of Ordinances of the City of Fort Lauderdale, Florida, (the "Code"), excludes the applicability of the Purchasing Division of the Code when waived by the City Commission by resolution; and

WHEREAS, the office furniture in the City of Fort Lauderdale Mayor's Office has not been replaced in 30 years; and

WHEREAS, Paradox Home Studio has provided a quotation for office furniture at a discounted cost; and

WHEREAS, Section 2-176(e)(19) of the Code excludes from the applicability of the Purchasing Division of the Code "[p]urchases of goods or services for which the provisions of this division are waived by the city commission by resolution"; and

WHEREAS, it would be in the City's best interest to approve the purchase of office furniture from Paradox Home Studio, and waive provisions of the Purchasing Division of the Code;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the recitals set forth above are incorporated in this Resolution.

<u>SECTION 2</u>. That the City Commission hereby adopts and approves the purchase of office furniture for the City of Fort Lauderdale Mayor's Office in the amount of \$9,715.

SECTION 3. That the provisions of Division 2, Purchasing, of Chapter 2, Article V of the

Code of Ordinances of the City of Fort Lauderdale, Florida, regarding competitive bidding, competitive quotes, and purchasing threshold amounts, are waived for the purchase of office furniture for the City of Fort Lauderdale Mayor's Office from Paradox Home Studio made pursuant to the attached quotation.
