TITLE:	Motion to Approve the 2018-2019 State Housing Initiatives Partnership (SHIP) Funds and Amend the 2017-2018 SHIP Funds and Program Income

Recommendation

It is recommended that the City Commission pass a motion accepting the 2018-2019 State Housing Initiatives Partnership (SHIP) program funds in the amount of \$234,978 permitting staff to use up to 10% of SHIP funds for administrative costs, and as program income is earned, set aside up to 5% for administrative costs; revising the 2017-2018 SHIP funds to pay the cost of home repairs for eligible homeowners; and authorizing the City Manager to execute all documents related to the acceptance and revision of the 2018-2019 and 2017-2018 allocations, respectively.

Background

The SHIP Program administered by Florida Housing Finance Corporation (FHFC) has been appropriated \$44,450,000 in funding for the 2018-2019 fiscal year. The City of Fort Lauderdale will receive \$234,978.00 (Exhibit 1) to be used for affordable housing strategies as per the approved 2016-2019 Local Housing Assistance Plan (LHAP) CAM #16-0253. In addition to the award of \$234,978, the estimated program income for FY 2018-2019 will be \$70,000 and program interest will be \$7,000.00. Total amount available for FY 2018-2019 will be \$311,978.

The funding requirements are as follows:

- A minimum of 20% of allocated SHIP funds be used to serve special needs persons with a priority to serve persons with developmental disabilities as defined in section 420.004, Florida Statutes.
- There is no required funding certification form for 2018-2019.

Housing and Community Development staff discussed which affordable housing strategies should be funded for FY 2018-2019 with the Affordable Housing Advisory Committee (AHAC) at the August 13, 2018 Advisory Meeting (Exhibit 2).

AHAC and Housing and Community Development staff are making the following 09/04/2018 Page 1 of 3 CAM # 18-0836 recommendations for the allocation of the \$234,978 FY 2018-2019 SHIP funding:

- 1. Owners Occupied Rehabilitation \$134,484.60
- 2. Project Service Delivery Costs- \$30,000.00
- 3. Special Needs \$46,995.60
- 4. Administration \$23,497.80

Revisions to the 2017-2018 SHIP funding include an additional SHIP distribution in the amount of \$3,067, additional program income in the amount of \$180,737.53 and interest in the amount of \$1,317.42 for 2017-2018 from repayment of SHIP loans. Total amount available from program income funds from FY 2017-2018 will be \$185,121.95.

Additionally, Housing and Community Development staff recommends that the City Commission approve the FY 2017-2018 revisions in the amount of \$185,121.95.

Resource Impact

Funding for this item is contingent upon the approval of the Consolidated Budget Amendment CAM# 18-0528.
