TITLE: Ordinance Amending Stormwater Management Rates

#### Recommendation

It is recommended that the City Commission approve an Ordinance amending Section 28-197, Code of Ordinances of the City of Fort Lauderdale, to increase the stormwater management rates to a monthly rate of \$12.00 per unit for residential units, \$120.96 per acre for commercial, industrial and residential units (greater than 3 units) and \$38.34 per acre for vacant land, parks and well fields.

### **Background**

Due to its unique geography, varied infrastructure conditions and the need for an increased level of service due to sea level rise and increased storm events, the City has identified significant investment needs in its stormwater infrastructure.

The City's Fiscal Year (FY) 2019 Budget includes a monthly stormwater management rate of \$12.00 for residential properties with three units or less, which is an increase of \$2.00 from the FY 2018 rates. The rate for commercial, industrial, and residential properties with more than 3 units is \$120.96 per acre which is an increase of \$20.16 from FY 2018 rates and the rate included for vacant land, parks, and well fields is \$38.34 per acre which is an increase of \$6.39 from FY 2018 rates. A stormwater rate study is underway. These rates will be in place until the new stormwater rates are approved. A rate comparison is provided.

# Stormwater Fee Effect of Monthly Increase on Neighbors

Residential <= 3 Units	\$10.00/unit	\$12.00/unit	\$2.00/unit
Commercial, Industrial, and Residential > 3 Units	\$100.80/acre	\$120.96/acre	\$20.16/acre
Vacant Land, Parks, and Well Fields	\$31.95/acre	\$38.34/acre	\$6.39/acre

## **Resource Impact**

There is no current year fiscal impact to the City. The revenues collected from stormwater charges are estimated to generate \$17.3 Million in FY 2019 to fund the City's Stormwater Management Program.
