

RESOLUTION NO. 18-144

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 18-130 TO RESCHEDULE THE PUBLIC HEARING BEFORE THE CITY COMMISSION FROM TUESDAY, **AUGUST 21, 2018** TO TUESDAY, **SEPTEMBER 4, 2018**, FOR CONSIDERATION OF THE TERMS OF THE LEASE AND AUTHORIZING EXECUTION OF SAME BY THE PROPER CITY OFFICIALS.

WHEREAS, the City Commission approved Resolution No. 17-169 on August 22, 2017; and

WHEREAS, the Resolution No. 17-169 provided for a Public Hearing on Tuesday, November 21, 2017 for consideration of a Lease between the City of Fort Lauderdale and Premier Parks, LLC; and

WHEREAS, by Resolution No. 17-261 the Public Hearing was extended to February 6, 2018; and

WHEREAS, on February 6, 2018, the City Commission by Resolution No. 8-20, extended the date until March 6, 2018; and

WHEREAS, by Resolution No. 18-38 the Public Hearing was extended to April 17, 2018; and

WHEREAS, by Resolution No. 18-72 the Public Hearing was extended to June 19, 2018; and

WHEREAS, by Resolution No. 18-110 the Public Hearing was extended to July 10, 2018; and

WHEREAS, by Resolution No. 18-130 the Public Hearing was extended to August 21, 2018; and

WHEREAS, the City Commission has agreed to delay the Public Hearing;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The Recitals are true and correct and incorporated herein by reference.


SECTION 2. That the Public Hearing scheduled for August 21, 2018 has been delayed until Tuesday, **September 4, 2018** at 6:00 pm, or as soon thereafter as can be heard, or such other date as the City Commission may designate, at City Hall at 100 North Andrews Avenue, Fort Lauderdale, Florida for purpose of reviewing the terms and conditions of the Lease.

SECTION 3. That the City Clerk shall cause this Resolution to be published in full in the official newspaper for two (2) issues, with the first publication at least ten (10) days before the date of the Public Hearing scheduled for **Tuesday, September 4, 2018** and the second publication five (5) days after the first publication.


SECTION 4. That this Resolution shall be in full force and effect immediately upon and after its passage.

SECTION 5. Resolution No. 18-130 remains in full force and effect, except as modified herein.
