

RESOLUTION NO. 18-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 18-167; EXTENDING THE BID OFFER DEADLINE TO NO LATER THAN 2:00 PM ON TUESDAY, **OCTOBER 30, 2018** AND EXTENDING THE DATE FOR PRESENTATION OF OFFERS TO THE CITY COMMISSION TO TUESDAY, **NOVEMBER 6, 2018** TO CONSIDER A RESOLUTION ACCEPTING THE BEST OFFER FOR SUCH PROPERTY AND AUTHORIZING CONVEYANCE OF SUCH PROPERTY OR REJECTING ANY AND ALL OFFERS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission approved Resolution No. 18-167 on September 4, 2018; and

WHEREAS, the Resolution provided for bid offers to be presented no later than 2:00 pm on September 18, 2018 and for presentation of offers to the City Commission on September 25, 2018; and

WHEREAS, the City did not receive bid offers on the property; and

WHEREAS, extending the dates for bids and acceptance of offers will allow for potential buyers to bid on the property.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The Recitals are true and correct and incorporated herein by reference.

SECTION 2. That the deadline for acceptance of bids has been extended until 2:00 pm on October 30, 2018.

SECTION 3. All bids must be submitted to City of Fort Lauderdale, Department of Finance, Procurement Division, 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016 on or before 2:00 pm, October 30, 2018.

SECTION 4. Review and acceptance of the bids by the City Commission shall be scheduled for 6:00 pm, or as soon t hereafter as same may be heard, on **November 6, 2018** at the Regular Meeting of the City Commission.

SECTION 5. That Resolution No. 18-167 shall remain in full force and effect, except as amended herein.

SECTION 6. Pursuant to City Charter Section 8.04, within seven (7) days after the adoption of this Resolution, this Resolution shall be published in full by the City Clerk in one (1) issue of the official newspaper.

SECTION 7. That this Resolution shall be in full force and effect immediately upon and after its passage.
