Mortgage in favor of SunTrust Bank

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Consent to Assignment of Lease, as amended, and an Assignment of Parking Facility Management Agreement from One Broward Blvd Holdings, LLC (the "Seller" or the "Tenant") to 1 East Broward Owner, LLC (the "Purchaser") and a Recognition, Attornment and Assent to Mortgage in favor of SunTrust Bank.

Background

On May 1, 2018 Commission approved the First Amendment to Amended and Restated Lease Agreement with One Broward Blvd Holdings, LLC. and a Parking Facility Management Agreement at the City Hall Garage at 200 NE 2nd Street.

The Seller intends to sell and convey its rights under the Amended and Restated Lease Agreement, as amended (the "Lease") to 1 East Broward Owner, LLC (the "Purchaser").

In connection with the sale, the Seller is seeking consent from the City to transfer Seller's interest in the Lease and in the Parking Facility Management Agreement to Purchaser. In accordance with Section 20(A) of the Lease, the Seller hereby requests the City's consent to such assignment by the City's execution of the Joinder and Consent to the Assignment of Lease and Assignment of Parking Facility Management Agreement. Additionally, in accordance with Section 28 of the Lease, the Tenant hereby requests the City's execution and return of the enclosed Tenant Estoppel Certificate addressed to the Purchaser.

Furthermore, the Purchaser is obtaining mortgage loan financing in which SunTrust Bank has requested approval and execution of a Recognition, Attornment and Assent Agreement between the City and the Purchaser as a condition of loan financing. The agreement provides for certain protections of the leasehold mortgage in favor of SunTrust Bank.

Resource Impact

There is no new fiscal impact associated with this action.
