Motion to Approve Funding of the Northwest-Progresso-Flagler Heights Community Redevelopment Area Mobility Master Plan in an amount not to exceed \$250,000

Chair Trantalis recognized Clarence Woods, Northwest Progresso-Flagler Heights CRA Manager. Mr. Woods explained the purpose of this motion is to provide funding for the Northwest Progresso-Flagler Heights Community Redevelopment Area (NWPFH CRA) Mobility Master Plan. It will include a review of a variety of data and extensive public outreach to create transportation improvements consistent with completed mobility master plans in six other neighborhoods. The method will include:

- A review of existing and future traffic conditions and related data;
- Access mitigation strategies;
- Transportation demand management strategies; and
- Creating an inventory of concerns including cut-through traffic, speeding, inadequate sidewalks, crosswalks, bicycle facility gaps, and road safety in order to address these items.

Chair Trantalis recognized Carla Roundtree, 722 NW 2nd Avenue. Ms. Roundtree requested a design of the Mobility Master Plan. It was noted this design is available in the item's Agenda backup. Executive Director Feldman explained the NWPFH CRA and its Mobility Master Plan. He said this item addresses a review of needs and strategies for the NWPFH CRA Mobility Master Plan. Further comment and discussions

ensued.

Commissioner McKinzie made a motion to approve this item and was seconded by Vice Chair Ben Sorensen.
