TITLE: Motion to Approve Contract for Fort Lauderdale Executive Airport Taxiway

Foxtrot Lighting Improvements – American Infrastructure Services, Inc. –

\$424,940

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Fort Lauderdale Executive Airport (FXE) Taxiway Foxtrot Lighting Improvements Project with American Infrastructure Services, Inc. (AIS) in the amount of \$424,940.

Background

The last substantial upgrade to the lighting and signage equipment along the western section of Taxiway Foxtrot was completed in 2002. Since that time, the aviation industry has begun to replace and upgrade the airfield lighting and signage equipment using more current light emitting diode (LED) technology as opposed to the existing quartz units. This LED technology has allowed for substantially more efficient and low-energy lighting fixtures and signs.

FXE has been systematically replacing its lighting and signage equipment with new LED units on a project-by-project basis. The contract work includes the replacement of airfield taxiway and guidance signage equipment with LED units as well as new cabling, conduits, and junction base cans. The design was completed by HDR Engineering, Inc., the Airport's engineering consultant.

On July 7, 2018, the Procurement Services Division issued Invitation to Bid Number 12161-283. Four bids were received on August 14, 2018, and all bids were reviewed for compliance with the solicitation specifications. The bid submitted by AIS has been deemed the lowest cost, responsive, and responsible bidder recommended for award.

Resource Impact

There will be a fiscal impact to the City in the amount of \$424,940 for the contract award and \$93,155 for estimated in-house and consultant project management fees for a project

total of \$518,095. Funds for this contract, in the amount of \$518,095, are available in the 2018 CIP account listed below:
