#### Recommendation

It is recommended that the City Commission approve an application for a temporary beach license and outdoor event agreement and authorize the City Manager to execute the agreement on behalf of the City of Fort Lauderdale with Greater Fort Lauderdale Pride, Inc. for Pride Fort Lauderdale Festival & Parade.

# **Background**

City staff has received a request from the Greater Fort Lauderdale Pride, Inc. for Pride Fort Lauderdale Festival & Parade to be held on Friday, Saturday and Sunday, February 22-24, 2019 on Fort Lauderdale Beach. Estimated attendance for this event is approximately 15,000 people.

City staff has been working closely with the event organizer regarding event topics such as logistics, maintenance, and security as detailed below. Amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. The agreement provides that the organizer will pay \$500 for each event use of the beach. The event organizer will secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding the event. Event details are included in the event application as attached.

Authorization for the execution of Event Agreements is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.
