TITLE: Motion to Approve Contract for Purchase of Roll-Off Hauling of Silts and
Sediments – MST Scrap Metal Inc d/b/a MST Dumpsters – \$241,200
(estimated three-year total)

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, for the purchase of roll-off hauling of silts and sediments from MST Scrap Metal Inc d/b/a MST Dumpsters (MST) in the three-year estimated total of \$241,200; and authorize the City Manager to approve one additional one-year renewal option contingent upon appropriation of funds.

Background

The City of Fort Lauderdale solicited through an Invitation to Bid (ITB) to qualified vendors for the hauling and disposal of street sweeping silts and stormwater silts generated through normal stormwater operations. These services were formerly provided using City staff and equipment but were transferred to an external hauler in FY 2018, reducing cost and improving the availability of staff to address infrastructure needs. On January 23, 2018, the City Commission approved an increase in expenditures to Contract 343-11406 with A.J. Panzarella L.L.C. (CAM #18-0073). In the CAM, staff committed to rebidding roll-off services for stormwater operations.

On August 9, 2018, the Procurement Services Division issued ITB 12179-893 for roll-off hauling of silts and sediments. On bid opening day, August 29, 2018, the City received a total of 4 bids. MST has met all of the specifications of the bid and has been deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a current fiscal year impact in the amount of \$80,400. Funds for this purchase are available in the FY 2019 Operating Budget in the accounts below listed.
