## **RESOLUTION NO. 18-181**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING THE TENTATIVE OPERATING MILLAGE RATE OF 4.1193 AND DEBT SERVICE MILLAGE RATE OF 0.0640 TO BE LEVIED BY THE CITY OF FORT LAUDERDALE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019.

WHEREAS, pursuant to applicable provisions of law, the City has computed a proposed millage rate and prepared a tentative budget for the fiscal year beginning October 1, 2018 and ending September 30, 2019; and

WHEREAS, a "Notice of Proposed Millage Rate and Tentative Budget Hearings" advising the public that a public hearing on the proposed millage rate and tentative budget would be held on September 6, 2018 at 6:00 P.M. in the City Commission Chambers at City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida has been published as required by Section 200.065, Florida Statutes; and

WHEREAS, said public hearing has been held as stated above and comments from the public concerning said proposed millage rate and tentative budget have been heard and considered; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Broward County has been certified by the County Property Appraiser to the City of Fort Lauderdale as \$36,476,192,981; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale, to adopt a tentative millage rate for the fiscal year beginning October 1, 2018 and ending September 30, 2019;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That there is hereby adopted a tentative millage rate to be levied on all property, both real and personal, in the City of Fort Lauderdale, Florida, subject to ad valorem taxation for operating purposes of 4.1193 mills on the dollar of taxable assessed valuation of \$36,476,192,981 for the fiscal year beginning October 1, 2018 and ending September 30, 2019 for the benefit of the General Fund of the City of Fort Lauderdale, and for the payment of the appropriations set forth in the operating budget, which levy is

designed to produce a total estimated tax collection of \$144,241,593, which millage rate results in 5.91% increase over the rolled back rate of 3.8893.

<u>SECTION 2</u>. That there is hereby adopted a tentative millage rate to be levied on all property, both real and personal, in the City of Fort Lauderdale, Florida, subject to ad valorem taxation for debt service purposes of 0.0307 mills on the dollar of taxable assessed valuation of \$36,476,192,981 for the purpose of paying interest and principal of the City's 2015 General Obligation Refunding Bond for the fiscal year beginning October 1, 2018 and ending September 30, 2019, which levy is designed to produce a total estimated tax collection of \$1,063,828.

<u>SECTION 3</u>. That there is hereby adopted a tentative millage rate to be levied on all property, both real and personal, in the City of Fort Lauderdale, Florida, subject to ad valorem taxation for debt service purposes of 0.0333 mills on the dollar of taxable assessed valuation of \$36,476,192,981 for the purpose of paying interest and principal of the City's 2011A General Obligation Bond for the fiscal year beginning October 1, 2018 and ending September 30, 2019, which levy is designed to produce a total estimated tax collection of \$1,153,924.

<u>SECTION 4</u>. That a public hearing to adopt a final millage rate and budget shall be held in accordance with Section 200.065, Florida Statutes.

<u>SECTION 5</u>. That this resolution will take effect immediately upon its adoption.
