A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 18-167; EXTENDING THE BID OFFER DEADLINE TO NO LATER THAN 2:00 PM ON, FRIDAY NOVEMBER 9, 2018 AND EXTENDING THE DATE FOR PRESENTATION OF OFFERS TO THE CITY COMMISSION TO TUESDAY, NOVEMBER 20, 2018 TO CONSIDER A RESOLUTION ACCEPTING THE BEST OFFER FOR SUCH PROPERTY AND AUTHORIZING CONVEYANCE OF SUCH PROPERTY OR REJECTING ANY AND ALL OFFERS; AND PROVIDING FOR AN EFFECTIVE DATE.

<u>SECTION 3</u>. All bids must be submitted to City of Fort Lauderdale, Department of Finance, Procurement Division, 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016 on or before 2:00 pm, November 9, 2018.

<u>SECTION 4.</u> Review and acceptance of the bids by the City Commission shall be scheduled for 6:00 pm, or as soon t hereafter as same may be heard, on **November 20, 2018** at the Regular Meeting of the City Commission.
