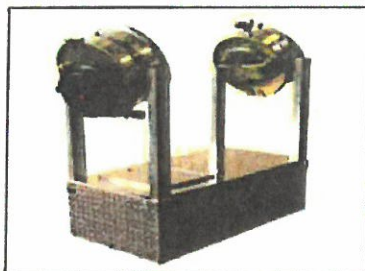




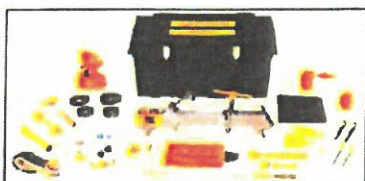

**Memorandum of Understanding**

It is hereby acknowledged that the equipment listed below were acquired utilizing South Florida Local Emergency Planning Committee (SoFlaLEPC)/South Florida Regional Planning Council (SFRPC) FY1415 and FY1516 Hazardous Materials Emergency Planning (HMEP) Grant Funds. While such grant funds are managed by SoFlaLEPC/SFRPC, they are administered through the Florida Division of Emergency Management (FDEM) and ultimately approved and provided by the U.S. Department of Transportation (DOT). These training props were recommended by the State Emergency Response Commission (SERC) Training Task Force and consequently selected by the SoFlaLEPC.



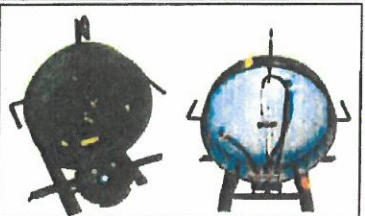




Description: Chlorine RailCar/Tank Truck Training Dome

The City of Fort Lauderdale Fire Rescue Department (FLFR) agrees to accept responsibility for the storage and general maintenance of this equipment with the following stipulations:


- FLFR will provide general maintenance while storing the equipment (replace old gaskets, etc.). FLFR will be responsible for the costs associated with restoring (or replacing) these resources if damaged while training in-house.
- These pieces of equipment are "regional assets" and therefore may be shared between the Hazardous Materials Teams in Broward, Miami-Dade, and Monroe Counties to assist in training. While in possession of an individual Agency/Hazmat Team for training purposes, that Agency/Hazmat Team assumes full responsibility for the costs associated with restoring (or replacing) these resources if damaged. The procedures for sharing equipment is as follows:
  - The Agency/Hazmat Team making the request to utilize these resources must coordinate mutually-agreeable times to pick up and return these resources with FLFR Training staff.
  - The resources must be returned in the same working order/condition as when borrowed. If not, the Agency/Hazmat Team borrowing the resources assumes full responsibility for the costs associated with restoring (or replacing) these resources if damaged.
- For multi-company training (several Hazmat Teams participating, multi-agency training, etc.), the costs associated with restoring (or replacing) these resources if damaged will be shared evenly between the Agencies/Hazmat Teams present at the training.

The purpose of this agreement is simply to formalize the understanding stated above and to express that such resources are to be considered regional assets and "sharable" within the SoFlaLEPC District, subject to the stipulations identified above. The term of the agreement shall be ten (10) years from the execution date, renewable for a five (5) year extension. The agreement is transferable to another District Fire Department with a HazMat Team by mutual agreement between the signees.
