TITLE: Motion to Accept a FY2018 National Sexual Assault Kit Initiative Grant –

\$238,031

Recommendation

It is recommended that the City Commission approve the acceptance of a grant in the amount of \$238,031 from the Department of Justice, Office of Justice Programs.

Background

In April 2018, the Police Department submitted a grant application under the National Sexual Assault Kit Initiative Competitive Grant program. The purpose of the program is to examine issues related to the handling of sexual assault kits (SAKs), develop and implement methodology to improve the processing and preservation of quality DNA evidence, and the provision of trauma-informed victim services. In September, the Police Department was notified of its award of \$238,031 in National Sexual Assault Kit Initiative funding in support of our proposal which will fund the testing of sexual assault kits, the preservation of investigative evidence, overtime for investigative follow up analysis of latent prints, and travel and training for Special Victims personnel. No matching funds are required. The grant performance period ends on or before September 30, 2021.

Resource Impact

There is an anticipated positive fiscal impact to the City in the amount of \$238,031. The grant does not require matching funds. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 18-1162.
