# MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF FORT LAUDERDALE AND THE FEDERATION OF PUBLIC EMPLOYEES

This Memorandum of Understanding is entered into this	day	of
, 2018 by and between the City of Fort Lauderdale, F	lorida, a	Florida
municipal corporation, hereafter referred to as the "City," and the Fed	eration of	Public
Employees, A Division of the National Federation of Public and Privi	ate Emp	loyees,
AFL-CIO, affiliated with District 1 - MEBA (AFL-CIO), hereinafter re	ferred to	as the
"Union." The City and the Union are collectively referred to as the "Parti	es."	

**WHEREAS**, the Parties entered into a Collective Bargaining Agreement for the period of November 7, 2017 to September 30, 2019 ("CBA"), which sets forth the terms and conditions of employment for the City's supervisory and professional bargaining unit; and

**WHEREAS**, Article 15 of the CBA, which contains the Parties' agreement with respect to wages, contains a reopener in Section 9 to negotiate the findings, recommendations or conclusions of the City's commissioned Classification and Compensation Study ("Class/Comp Study") relative to bargaining unit classifications; and

**WHEREAS**, the Parties desire to modify Article 15 of the CBA, the related appendices, as well as the City classification pay plan to implement the recommendations set forth in the Class/Comp Study and below and to address related matters.

#### **NOW, THEREFORE**, the Parties agree as follows:

- 1. The above recitals are true and correct and incorporated herein by reference.
- 2. Article 15 of the CBA is amended as follows:<sup>1</sup>

#### **ARTICLE 15 - RATES OF PAY**

<u>Section 1</u>. An employee's pay rate will be increased approximately one and one-half percent (1.5%) based upon an overall performance of satisfactory, and three percent (3%) based upon an overall performance of above satisfactory <u>or outstanding</u>, in accordance with the established pay ranges for each classification in the Professional and Supervisory Units upon recommendation of the department head and with approval of the City Manager. An employee whose overall performance rating is marginal or unsatisfactory shall receive no merit increase at that time, but may be rated again in three (3) months. While increases within the appropriate pay range for unusual or

meritorious service may be granted without regard to limitation of time, progression through the applicable pay range for the classification shall normally be considered at twelve (12) month intervals. An employee's anniversary date for the purpose of eligibility for merit increase shall be the effective date of the employee's most recent date of promotion.

#### Section 8. Certification Pay

- A. Ocean-Rescue Beach Patrol Lieutenants:
  - 1. Ocean-Rescue Beach Patrol Lieutenants shall be eligible to receive either EMT or Paramedic certification pay as provided below:

Emergency Medical Technician (EMT) 10% of employee's basic hourly rate of pay

Paramedic (PM) 15% of employee's basic hourly rate.

\* \* \*

<u>Section 9</u>. The parties agree that upon completion of the City's ongoing Classification and Compensation Study, this Article, together with Appendix A, B, and E of this Agreement, may be reopened by either party for the purpose of negotiations over the findings, recommendations, or conclusions of the study with regard to bargaining unit classifications.

Appendix A of the CBA is deleted in its entirety and replaced with a new Appendix A, which reads as follows

- 8. The Parties agree that this Memorandum of Understanding represents the Parties' entire agreement and it cannot be amended or modified without the express consent of the Parties.
- 9. The Parties have had the opportunity to consult with legal counsel of their choosing.
- 10. The Parties signify their agreement with this Memorandum of Understanding by affixing their signatures below.
- 11. This Memorandum of Understanding shall become effective the date on which it is fully ratified by the Parties.
