TITLE: Motion to Reject all Bids and Rebid Comprehensive Parking Demand

Management System

Recommendation

It is recommended that the City Commission reject all proposals received in response to Request for Proposals ("RFP") 12109-885 Comprehensive Parking Demand Management System and find that the public interest will be served thereby.

Background

The City of Fort Lauderdale solicited an RFP from qualified professional firms to provide a smart comprehensive parking demand management system ("CPDMS"). The submissions were to demonstrate how the City of Fort Lauderdale parking operations would assess and implement a parking demand (dynamic pricing) and enforcement system. The proposing firms were asked to provide enhancements and interoperability with the City's parking equipment to meet the City's need to enhance parking utilization and meet the City's goal of less traffic congestion.

The background of the solicitation process includes the following:

- February 22, 2018 RFP 12109-885 was issued for a CPDMS.
- May 2, 2018 The RFP closed with a total of eight firms submitting proposals. Four
 of these firms were deemed non-responsive for not submitting the mandatory
 bid bond.*
 - 1. Conduent State & Local Solutions, Inc. ("CSLS")
 - 2. IPS Group, Inc. ("IPS")
 - 3. Passport Labs, Inc. ("PLI")
 - 4. SICE Inc. ("SICE")
 - 5. * Focus Engineering, LLC Non-Responsive
 - 6. * Frog Parking Non-Responsive
 - 7. * Mathom Inc. | SEPP-Parking Non-Responsive
 - 8. * T2 Systems, Inc. Non-Responsive

May 30, 2018 - The evaluation committee, consisting of five committee members –
Juan Rodriguez, Transportation and Mobility ("TAM"), Business Manager; Bryan
Greene, TAM, Assistant Parking Services Manager; Jennifer Peters, Information
Technology, Senior Technology Strategist; Linda Picciolo, Finance, Administrative
Assistant I; and Ron Oster, Broward County Aviation Department, Airport Manager,
met with Laurie Platkin, Procurement Specialist II, to evaluate and rank the firms
based on the following evaluation criteria:

- On June 13, 2018 the four top raked firms provided presentations to the review committee followed by question and answer sessions. The final tabulation of the review committee scoring ranked the four firms as follows:
 - 1. PLI
 - 2. SICE
 - 3. CSLS
 - 4. IPS

Upon a thorough review of the solicitation, staff determined that revisions to the solicitation would be in the best interest of the City. As such, staff recommends all bids be rejected to greater clarify the specifications. Staff will re-bid the project after adjusting the specifications to greater address the technology and pricing needs of the project.

Resource Impact

There is no fiscal impact to the City.
