TITLE: Motion Authorizing Purchase of Reinsurance for Self-Funded Medical Plan

- Cigna Health and Life Insurance Company - \$1,044,386

Recommendation

It is recommended that the City Commission approve the purchase of a one-year reinsurance policy with a stop-loss level of \$325,000 for the self-funded medical plan from Cigna Health and Life Insurance Company (Cigna) in the estimated amount of \$1,044,386.

Background

The City of Fort Lauderdale's self-funded medical plan design includes a fully insured specific reinsurance policy that covers all incurred medical and pharmacy claims in excess of a designated amount per member per calendar year. This coverage is also known as a specific stop loss policy. These reinsurance policy premiums are only guaranteed for one year at a time and renewals are based on local industry medical cost trends, policy experience, and an insurance company's overall experience in their reinsurance pool.

The City of Fort Lauderdale's current reinsurance policy is underwritten by Cigna and will expire on December 31, 2018. The City's contracted agent, Lloyd Rhodes of The Rhodes Insurance Group, approached the available markets and found Cigna, the current vendor, as the only responsive bidder. Eight other markets declined to quote and considered themselves to be non-competitive. Cigna offered a 0.3% increase in premium (\$49.31 per subscriber, per month, up from \$49.16) while increasing the stop loss level to \$325,000. The total estimated premium of \$1,044,386 is based on enrollment of 1,765. If the enrollment number increases throughout the Plan Year, the total premium will have to be increased. This policy is for the period of January 1, 2019 through December 31, 2019. There was not a quorum for the November 7, 2018 meeting of the Insurance Advisory Board so this item was not reviewed by the Board.

Staff, and the City's Benefits Consultant, requests City Commission approval for the purchase of reinsurance from Cigna Health and Life Insurance Company in the estimated amount of \$1,044,386.

Resource Impact

There will be an estimated fiscal impact to the City in the amount of \$1,044,386 for this contract of insurance.
