The purpose of this Amendment is to renew the Contract for a period of one year, pursuant to Section III., A., 2., of the Contract.

THIS AMENDMENT, entered into between the STATE OF FLORIDA, DEPARTMENT OF JUVENILE JUSTICE, ("Department") and CITY OF FORT LAUDERDALE ("Provider"), amends the above-referenced Contract by deleting, as indicated by "strikethrough" or reference and adding, as indicated by "underline" or reference the section(s) below:

REFERENCE: Page 2, Section III., A., Contract Term (as amended by Amendment #3)
UPDATE: 1. This Contract shall begin on ~~September 24, 2015~~, or upon full execution, whichever is later, and shall end at 11:59 P.M. on ~~August 31, 2018~~ August 31, 2019. In the event the parties sign this Contract on different dates, the latter date shall be the effective date.

REFERENCE: Page 3, Section III., B., 1., Contract Amount (as amended by Amendment #3)
UPDATE: Total compensation under this Contract shall not exceed ~~\$83,334.00~~ \$111,108.00. This is a fixed price (unit cost) Contract. The Department shall pay the Provider for the delivery of service units provided in accordance with the terms of this Contract.
