

**DEPARTMENT OF JUVENILE JUSTICE  
FOURTH CONTRACT AMENDMENT

The purpose of this Amendment is to renew the Contract for a period of one year, pursuant to Section III., A., 2., of the Contract.

**THIS AMENDMENT**, entered into between the **STATE OF FLORIDA, DEPARTMENT OF JUVENILE JUSTICE**, ("Department") and **CITY OF FORT LAUDERDALE** ("Provider"), amends the above-referenced Contract by deleting, as indicated by "~~strike through~~" or reference and adding, as indicated by "underscore" or reference the section(s) below:

**REFERENCE:** Page 2, Section III., A., Contract Term (as amended by Amendment #3)  
**UPDATE:** 1. This Contract shall begin on ~~September 24, 2015~~, or upon full execution, whichever is later, and shall end at 11:59 P.M. on ~~August 31, 2018~~ August 31, 2019. In the event the parties sign this Contract on different dates, the latter date shall be the effective date.

**REFERENCE:** Page 3, Section III., B., 1., Contract Amount (as amended by Amendment #3)  
**UPDATE:** Total compensation under this Contract shall not exceed ~~\$83,334.00~~ \$111,108.00. This is a fixed price (unit cost) Contract. The Department shall pay the Provider for the delivery of service units provided in accordance with the terms of this Contract.
