A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE FINAL BUDGET OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019, AS AMENDED, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #18-1313, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution Nos. 18-192, adopted on September 12, 2018, the City Commission of the City of Fort Lauderdale, Florida, adopted the Final Budget of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2018, and ending September 30, 2019;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Final Budget of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2018, and ending September 30, 2019, as amended, is hereby amended by appropriating funds as set forth in Commission Agenda Memo #18-1313, a copy of which is attached hereto and incorporated herein.

SECTION 2. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution Approving the Consolidated Budget Amendment to Fiscal Year
2019 – Appropriation

Recommendation

It is recommended that the City Commission adopt a resolution amending the Fiscal Year (FY) 2019 Budget.

Background

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff recommends that the City Commission amend the FY 2019 Operating Budget:

City Clerk

A. Appropriation of Fund Balance – General Fund – General Obligation Bonds Elections - \$325,000

Two General Obligation Bond referendums will be placed on the March 12, 2019 ballot. The estimated cost for pollworker services is \$325,000.

Staff recommends that the City Commission amend the FY 2019 Operating Budget in the amount of \$325,000 for pollworker services for a March 12, 2019, special election. There is an associated CAM #18-1311.

B. Appropriation of Unanticipated Revenue and Expense – General Fund – Communications Plan for General Obligation Bonds Elections - \$100,000

Two General Obligation Bond referendums will be placed on the March 12, 2019 special election ballot. In order to educate and inform our neighbors about the Parks and Recreation and Public Safety bond proposals, City staff recommends hiring an experienced company to develop and implement a communications plan.

The City has been notified by the Department of Revenue that an upward adjustment will be made to the City's distribution of Communications Service Tax estimate included in the Fiscal Year 2019 budget. This increase in revenue is available to be appropriated to fund the unbudgeted expense related to the communications plan.

Staff recommends that the City Commission amend the FY 2019 Operating Budget in the amount of \$100,000 to appropriate unanticipated Communication Service Tax revenue to fund a consultant to develop and implement a communications plan.
