TITLE: Resolution to Approve an Application for Dock Permits for Usage of Public
Property by (a) Olas Capital LLC located at 341 Idlewyld Drive and (b)
James D. Wilson located at 333 Poinciana Drive

Recommendation

It is recommended that the City Commission adopt a resolution granting a dock permit for use by private persons of public property for Olas Capital LLC located at 341 Idlewyld Drive & James D. Wilson located 333 Poinciana Drive, Fort Lauderdale, Florida.

Background

The applicant is seeking a resolution granting two dock permits for use by private persons of public property in accordance with Section 8-144, Code of Ordinances of the City of Fort Lauderdale, for the construction use, maintenance and repair of two proposed 4 feet x 25 feet finger piers and associated mooring piles and a repaired and raised seawall adjacent to (a) 341 Idlewyld Drive and (b) 333 Poinciana Drive.

The resolution (Exhibit 4) grants a permit for the construction and maintenance of a finger pier and associated mooring piles to (a) Olas Capital LLC at 341 Idlewyld Drive and (b) James D. Wilson at 333 Poinciana together with the responsibility and cost for demolishing the finger piers and mooring piles and repair and raising of the associated seawall to the City's required height.

Although there is not a fee associated with obtaining a permit for usage by private persons of public property, an application fee in the amount of \$300 is required. The Marine Advisory Board recommended approval of the application 8 to 2 (Exhibit 3).

Resource Impact

There is a positive impact in the amount of \$300. Revenue related to this application is included in the FY2019 operating budget in the account listed below:
