TITLE: Motion Approving a Revised Temporary Beach License and Outdoor

Event Agreement with Greater Fort Lauderdale Pride, Inc. for a two-day

Event on Fort Lauderdale Beach

### Recommendation

It is recommended that the City Commission approve a revised application for a temporary beach license and outdoor event agreement and authorize the City Manager to execute the agreement on behalf of the City of Fort Lauderdale with Greater Fort Lauderdale Pride, Inc. for Pride Fort Lauderdale Festival & Parade. The changes made from the original event application include an additional location, changes to the set-up date and removal of Friday event, Saturday Parade and Event Changes, and added food and bars to parade route. The specific event changes are included in Exhibit 1b.

#### **Background**

This event permit was approved at the October 9, 2018 Commission Meeting (CAM 18-0859). The promoter is now requesting revisions from the approved event application. The Greater Fort Lauderdale Pride, Inc. is requesting to hold Pride Fort Lauderdale Festival & Parade on Saturday and Sunday, February 23-24, 2019 on Fort Lauderdale Beach. Estimated attendance for this event is approximately 30,000 people.

City staff has been working closely with the event organizer regarding event topics such as logistics, maintenance, and security as detailed below. Amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. The agreement provides that the organizer will pay \$500 for each event use of the beach. The event organizer will secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding the event.
