#### Recommendation

It is recommended that the City Commission approve a resolution authorizing the execution of a Non-Exclusive Master Utility License Agreement with Florida Power & Light Company for installation of utility lines and facilities for Parcels 9, 32, 33 at Fort Lauderdale Executive Airport.

#### **Background**

Sheltair FXE Northside, LLC (Sheltair) leases Parcels 9, 32, 33 (Exhibit 1) at Fort Lauderdale Executive Airport (FXE) which consists of 19.329 acres under terms of a lease expiring in October 2045. Sheltair seeks to further improve the property by replacing the existing buildings and redevelop the entire property with modern facilities valued at \$25,000,000.00. The improvements will consist of eight (8) corporate sized hangars with attached offices, workshops, and one (1) terminal lobby.

To fully develop the site, a License Agreement between the City of Fort Lauderdale and Florida Power & Light Company is required for the installation of utility lines and facilities (Exhibit 2). In addition to the installation of facilities, the Agreement ensures restoration of service and application of wind resistant technologies when able. Staff from the Airport has reviewed the Agreement and finds it acceptable.
