TITLE: Motion to Approve Contract for the Annual Sidewalk, Asphalt, and Paver Emergency Repair Services – FG Construction, LLC and R&G Engineering, Inc. - \$150,000

Recommendation

It is recommended that the City Commission award two, two-year contracts in substantially the forms attached, to FG Construction, LLC ("FG") and R&G Engineering, Inc., ("R&G"), for the annual sidewalk, asphalt, and paver emergency repair services, in the estimated aggregate amount of \$150,000 and authorize the City Manager to approve two, one-year renewal options contingent upon appropriation of funds.

Background

The scope of work includes installation of 6-inch thick concrete sidewalk, various curbs, brick pavers, limerock base of various depths, type S-3 asphaltic concrete, thermoplastic pavement marking, ADA concrete ramps, removal of asphalt, tree roots and other items quantified in the proposal pages of this contract. Work will be assigned on an as-needed basis. The contract sum is an estimate and not a guarantee of the amount of work that will be assigned.

On December 7, 2018, the Procurement Services Division issued Invitation to Bid Number 12218-693. Four bids were received on January 8, 2019, and all bids were reviewed for compliance with the solicitation specifications. The bids submitted by FG and R&G were reviewed for compliance with the specifications of the bid, and have been deemed the lowest cost, responsive, and responsible bidders recommended for award.

Each awarded vendor will be issued a blanket purchase order in the amount of \$75,000. However, to ensure the City's operational needs are met, the blanket purchase orders may be adjusted as needed within the approved contract value of \$150,000.

Resource Impact

There will be a fiscal impact to the City in the amount of \$150,000 for these contract awards. Funds for this purchase in the total amount of \$150,000 are available in the FY 2019 Operating Budget in the accounts listed below:
