**TITLE:** Motion to Approve Contract for Purchase and Installation of Playground  
Equipment at Bayview Park – TopLine Recreation Inc. - \$241,451.90

---

**Recommendation**

It is recommended that the City Commission approve a contract, in substantially the form attached, for the purchase and installation of playground equipment at Bayview Park from TopLine Recreation Inc. ("TLR") via the School District of Osceola County Contract #SDOC-16-B-087-LH in the amount of \$241,451.90.

**Background**

The playground at Bayview Park was installed in 2006 and has exceeded its useful life. The conditions of several play elements have deteriorated to the point where several sections have had to be closed off. The remainder of the play structure may have to be closed off at any moment. The result of this project will provide a safe and accessible playground for neighbors and visitors.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may piggyback a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the chief procurement officer determines that it is practicable and advantageous for the city to employ this method of procurement. The chief procurement officer has determined that it would be practicable and advantageous for the city to use this method of procurement for this agreement. This purchase will be made in accordance with the School District of Osceola County Contract SDOC-16-B-087-LH from TLR in the amount of \$241,451.90.

**Resource Impact**

There is a fiscal impact to the City in the amount of \$241,451.90. This item is contingent upon the approval of the Consolidated Budget Amendment CAM #19-0025.
