**TITLE**: Motion to Approve Contract for the Purchase of Criminal Defense Attorney

Services – Law Offices of Steven A. Schaet LLC - \$168,000

#### Recommendation

It is recommended that the City Commission approve a two-year contract, in substantially the form attached, for the purchase of criminal defense attorney services from the Law Offices of Steven A. Schaet LLC in the amount of \$168,000 and authorize the City Manager to approve two, one-year renewal options contingent upon appropriation of funds.

# **Background**

The City Attorney's Office prosecutes municipal ordinance violations in the County Court in and for Broward County, Florida, pursuant to Section 4.12, Charter of the City of Fort Lauderdale, Florida. Broward County Court judges appoint attorneys to represent indigent defendants in these municipal ordinance violation proceedings.

The City of Fort Lauderdale ('City") solicited and evaluated proposals for these services. The background of the solicitation process includes the following:

- In January 2019, the Procurement Services Division issued Request for Proposals ("RFP") No. 12212-995 Criminal Defense Attorney Services
- In February 2019, the RFP closed with the three firms below submitting proposals:

- In March 2019, the evaluation committee met and ranked the firms as follows:
  - 1. Law Offices of Steven A. Schaet LLC
  - 2. The McLawrence Law Firm
  - 3. William T. Direnzo, PA

Staff recommends awarding the contract for criminal defense attorney services to the Law Offices of Steven A. Schaet LLC.
