TITLE:	Motion Approving the Acceptance of Equipment from Broward County Healthcare Coalition via Davie Fire Rescue in the amount of \$940.41

#### **Recommendation**

It is recommended that the City Commission approve a motion authorizing the Fire Chief to accept a donation of equipment from the Broward County Healthcare Coalition via Davie Fire Rescue and to execute any documents required to accept the equipment between Davie Fire Rescue and the City of Fort Lauderdale.

#### **Background**

FLFR strives to have 50% of their patients have return of spontaneous circulation (ROSC) if they have been in cardiac arrest. With the assistance of utilizing a real-time data feedback mannequin, FLFR has the opportunity to increase ROSC to the neighbors and visitors of Fort Lauderdale, Wilton Manors and Lazy Lake.

Broward County Healthcare Coalition (BCHC) has received a grant to assist fire rescue agencies with ROSC by providing Laerdal Quality Cardiopulmonary Resuscitation (QCPR) Little Anne (4-pack) manikins to members of BCHC via Davie Fire Rescue. The provided manikins will help change a long standing culture, which does not stress the significance of the core competencies of CPR and the direct connection to patient survival. High performance/quality CPR stresses the significance of these core competencies with practice on feedback mannequins, creating muscle memory for greater effectiveness to the first responder.

High Performance/Quality CPR typically consists of proficiently performed basic life support (BLS) with strict attention to:

Minimally interrupted chest compressions:
Ensuring optimal rate (100-120)
Ensuring adequate depth (2 – 2.4" or 5 – 6 cm)
Allowing full chest recoil

The QCPR Feedback manikins will significantly improve the training capability of Fort Lauderdale Fire Rescue personnel to respond and properly treat patients suffering from cardiac arrest by proficiently performing CPR. The need to provide immediate and highly effective CPR to patients suffering from cardiac arrest is critical. With proper compression rate, depth and recoil, successful return of spontaneous circulation (ROSC) will provide patients with the greatest opportunity of survival. These manikins will help bridge the gap from prehospital to hospital continued quality of care.

Fort Lauderdale Fire Rescue will receive the following pieces of equipment:

• One (1) set – Laerdale QCPR Little Anne manikins = \$940.41

FLFR's Training and Special Operations Bureau projects an improvement of ROSC rates to cardiac arrest patients by utilizing the acquired manikins during Advanced Cardiac Life Support (ACLS) and Pediatric Advanced Life Support (PALS) classes that are conducted twice annually February/March and August/September to all Fort Lauderdale Fire Rescue employees.

### **Resource Impact**

There is no fiscal impact to the City.
