TITLE:	Motion to Approve Contract for the Demolition and Abandonment of Pur Stations A-44, A-97 and C-3 – Sun-Up Enterprises Inc \$227,577				

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the demolition and abandonment of Pump Stations A-44, A-97 and C-3 project with Sun-Up Enterprises Inc., in the amount of \$227,577.

Background

The purpose of this project is to remove and dispose of all mechanical, electrical, ventilation equipment at the stations, cut and backfill stations below ground, and subsequently restore all sites. All three pump stations are being abandoned due to the availability of gravity sewers.

On November 8, 2018, the Procurement Services Division issued Invitation to Bid Number 12100-693. Eight bids were received on January 10, 2019, and all bids were reviewed for compliance with the solicitation specifications. LCCI Construction, LLC was deemed non-responsive due to the omission of two of the bid items. The bid submitted by Sun-Up Enterprises Inc. has met all of the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$227,577 for construction and \$22,758 for estimated in-house project management fees for a total cost of \$250,335. Funds for this contract in the amount of \$250,335 are available in the FY 2019 Community Investment Plan in the account listed below.
