TITLE: Resolution Granting a Waiver of Limitations at 1180 N. Federal Highway
#1201, Slip #14, for the Installation of a Four-post Boat Lift

Recommendation

It is recommended that the City Commission adopt a resolution granting a Waiver of Limitations for the installation of a four-post boat lift located at 1180 N. Federal Highway #1201, Slip #14.

Background

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 (C) of the Unified Land Development Regulations (ULDR) for the installation of a four-post boat lift extending a maximum distance of +/- 30 feet from the property line into the Middle River.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$300.00 is required.

The Marine Advisory Board recommended unanimous approval of the application 9 to 0 (see Exhibit 3).
