

RESOLUTION NO. 19-84

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, PURSUANT TO SECTION 47-19.3(E) OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE GRANTING A WAIVER OF THE LIMITATIONS OF SECTION 47-19.3 (C) TO ALLOW KENNETH M. RICKETTS, FOR INSTALLATION OF A BOAT LIFT THAT WILL EXTEND A MAXIMUM OF $\pm 43'$ INTO THE MIDDLE RIVER SUCH PROPERTY BEING LOCATED AT 1 HENDRICKS ISLE, AND MORE PARTICULARLY DESCRIBED BELOW; SUBJECT TO CERTAIN TERMS AND CONDITIONS; REPEALING ANY AND ALL PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Kenneth M. Ricketts, (hereinafter "Applicant") owns the following described Property located in the City of Fort Lauderdale, Broward County, Florida:

(hereinafter "Property")

WHEREAS, Applicant is requesting approval for installation of a boat lift which will extend a maximum of $\pm 43'$ from the Applicant's property line into the waters of Middle River; and

WHEREAS, the City's Marine Advisory Board on March 7, 2019, reviewed the application for dock waiver filed by the Applicant and voted unanimously to recommend approval.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That pursuant to the provisions of ULDR Section 47-19.3(E) of the Code of Ordinances of the City of Fort Lauderdale, the City Commission hereby grants a waiver of the limitations of ULDR Section 47-19.3(C), to allow Applicant to install a boat lift extending from Applicant's property line into the waters of the Middle River such distances being more specifically set forth in the Table of Distances set forth below:

SECTION 2. That the above waiver is subject to the following additional conditions to be performed by the Applicants:

1. The Applicant is required to comply with all applicable building and zoning regulations as well as any other Federal and State laws and permitting requirements including the Broward County Environmental Protection and Growth Management Department, the Florida Department of Environmental Protection and the U.S. Army Corps of Engineers.
2. As a general condition of approval and in order to review for final consistency with construction of facilities in accord with this application and City building permits the Applicant is required to provide the City's Supervisor of Marine Facilities with copies of "As Built" drawings from a certified and licensed contractor and verification of all applicable Federal and State permits.
3. Use of the upland townhouse residence and occupation thereof shall be in conformity with the City's ULDR and other applicable municipal, county, state and federal laws, rules, regulations and ordinances, including, but not limited to City Codes, Unified Land Development Regulations and City's Minimum Housing Code, as same may be amended from time to time.
4. In accordance with City Code Sec. 8-149, repair and/or maintenance of vessels moored at this location shall be permitted only when such repair or maintenance is routine or minor in nature and does not involve major exterior alteration, rebuilding, complete refinishing, and/or removal of machinery, or the use of tools and equipment in such repair or maintenance which would be in violation of City Code of Ordinances, Chapter 17, Noise Control. Repair or maintenance, whether major or minor, shall be permitted in residential areas if such necessary work is conducted wholly within the confines of a permanent enclosed structure, and so long as the work complies with all other applicable City ordinances.

5. Within ninety (90) days of adoption of this Resolution, Applicants shall file applications for permits for all other governmental or regulatory approvals required to implement the dock waiver herein and provide proof thereof to the Supervisor of Marine Facilities. In the event the Applicant fails to timely file applications for permits as referenced above, the granting of this waiver will expire, without prejudice to the Applicant re-filing a subsequent application for dock waivers.
6. The Applicant shall complete construction of the improvements as reflected in the application for the waiver of limitations through to a final certificate of completion no later than 180 days after issuance of all necessary permits. In the event the Applicant fails to timely file applications for permits as referenced above, the granting of this waiver will expire, without prejudice to the Applicant re-filing a subsequent application for dock waivers.
7. The renting of docks, dock space or moorings, and the rental of boats or any portion thereof, for any purpose whatsoever shall be specifically prohibited except liveaboards in certain zoning districts depending on the density.
8. In the event ownership of the Property is transferred to a third party prior to issuance of a building permit to construct the improvements authorized under this dock waiver Resolution, then this Resolution shall become null and void.
9. Violation of any of the foregoing conditions is unlawful and constitutes a violation of the City's ULDR and may result in revocation of this Resolution by the City Commission.
10. A copy of this Resolution shall be attached to each and every Lease Agreement for the leasing of the Property described herein.
11. That a certified copy of this Resolution shall be recorded in the Public Records of Broward County, Florida, at Applicants' expense, within thirty (30) days of final passage.
12. The Applicant is required to install and affix reflector tape to the proposed mooring piling clusters in accordance with Section 47.19.3.(e) of the Unified Land Development Regulations.
13. No vessel moored at this site shall extend beyond the outside edge of the outermost triple-pile cluster.

SECTION 3. That all Resolutions or parts of Resolutions in conflict with this Resolution are hereby repealed.

SECTION 4. That this Resolution shall be in full force and effect upon and after its final passage.

EXHIBIT "A"

UNIT 1, RIO LAS OLAS, LOCATED AT 1 HENDRICKS ISLE, FORT LAUDERDALE, FLORIDA 33301, MORE PARTICULARLY DESCRIBED AS:

LOT 18 LESS THE NORTH 16.83 FEET THEREOF, BLOCK 3 OF UNIT A LAUDERDALE ISLES, ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 9, PAGE 28, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA;

Together with that part of land Southerly of Block 3, according to the Plat of UNIT A, LAUDERDALE ISLES, as recorded in Plat Book 9, at Page 28, of the Public Records of Broward County, Florida, lying Southerly of and adjacent to Lot 18, described as follows:

Beginning at the Southeast corner of said Lot 18 in Block 3, according to said Plat; thence run South $80^{\circ}15'00''$ West, (on an assumed bearing) 92.10 feet along the Southerly boundary of said Lot 18 to a point of curvature of a curve to the right; thence along said Southerly boundary on the arc of said curve to the right, having a radius of 25 feet and a central angle of $99^{\circ}45'$, run Northwesterly 43.52 feet; thence run due South 12.15 feet along the Southerly projection of the Westerly boundary of said Lot 18, also forming the face of the existing bulkhead, as now located and constructed, to a point of curvature of a curve to the left; thence along said existing bulkhead on the arc of said curve to the left, having a radius of 25 feet and a central angle of $99^{\circ}02'37''$, run Southeasterly and Northeasterly 43.22 feet to a point of tangency; thence run North $80^{\circ}57'23''$ East, 92.22 feet along said existing bulkhead line, being the tangent extended, to an Intersection with the South projection of the East Boundary of said Lot 18; thence run due North 13.30 feet along said projection to the POINT OF BEGINNING, said land situate in the City of Fort Lauderdale, Broward County, Florida.
