A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY, APPROVING THE TRANSFER OF FUNDS FROM THE CAPITAL INVESTMENT PROJECT BALANCES TO EXISTING COMMUNITY INVESTMENT PROJECTS; AND PROVIDING FOR AN EFFECTIVE DATE.

TITLE: Resolution to Approve Budget Amendment – Motion to Abandon and Appropriate Eight (8) Northwest Progresso Flagler Heights (NPF) Community Investment Projects – **(Commission Districts 2 and 3)**

Recommendation

It is recommended that the Community Redevelopment Agency (“CRA”) Board of Commissioners approve the Budget Amendment to abandon and appropriate unspent Capital Investment Project balances totaling \$1,331,354 to existing Community Investment Projects (CIPs).

Background

On June 19, 2018 the City Commission authorized Florida Power and Light Company (“FPL”) to prepare cost estimates necessary to relocate the utility lines to facilitate new development located at 543 NW 5th Avenue. The CRA Board of Commissioners approved the deposit of \$143,080 as preliminary steps for these services on June 19, 2018 (CAM 18-0630). FPL previously provided a non-binding preliminary estimate of \$1,361,600 for the relocation of the transmission line that bisects the property. The Sistrunk Phase II Underground Utilities was established for both the relocation of FPL utility lines for 543 NW 5th Avenue and the undergrounding of utility lines on Sistrunk Boulevard between NW 9th Avenue and The FEC railway. The proposed fund transfer into the Sistrunk Phase II Underground Utilities Project will help to cover project budgets and successfully complete these services.

On July 14, 2011 the City Commission approved the Northwest 7th/9th Avenue Connector Project to reduce traffic congestion and facilitate more efficient traffic flow along Sunrise Boulevard. The authorization to appropriate multiple funding sources for this project was necessary to keep CRA and Grant funding separate. At the end of the project, the Miscellaneous Federal/State/County Grant fund was left with a negative balance and the Northwest Progresso Flagler Heights (“NPF”) CRA CIP was left with a positive balance. To help offset the negative balance left in the Northwest 7th/9th Avenue Connector Project, a proposed fund transfer into the Miscellaneous Federal/State/County Grant fund is needed.

Staff recommends the following Budget Transfers to Capital Investment Projects:

(A) The Northwest Progresso Flagler Heights CRA FY 2019 Community Investment Project balances of \$1,316,874; \$93,938 from the BCIP Flagler Village Project, \$437,624 from the NW Neighborhood Pedestrian Pathway Project, \$183,881 from the Northwest 9th Avenue Project, \$600 from the 2011 NCIP Midtown Business Association Streetscape, \$583,638 from the Flagler Arts and Technology Village Corridor Improvements Project, \$622 from the Carter Park Renovations and \$16,571 from the Lighting at Provident Park Project to the Sistrunk Phase II Underground Utilities Community Investment Project (P12096.347).

(B) The Northwest 7th/9th Avenue Connector Community Investment Project balance of \$14,480 (P09295.347) to the Miscellaneous Federal/State/County Grant Fund (P09295.129).

Consistency with the NPF CRA Community Redevelopment Plan

The Community Redevelopment plan encourages the development of infrastructure necessary to support the Northwest Regional Activity Center. The Redevelopment Plan will assist in providing public amenities and incentives as inducements to stimulate private development. The installation of public utilities will stimulate the development of the area necessary to attract development. The City and the CRA considers the Sistrunk corridor public improvements important to the successful redevelopment and revitalization of the redevelopment area, and the community redevelopment program and strategies states that priority consideration shall be given first to the funding and implementation of improvement projects that through the upgrades to infrastructure will improve the neighborhoods area, provide infrastructure support to businesses and commercial sectors, foster thriving businesses and commerce in the CRA.

Commercial nodes will help revitalize Sistrunk as a mixed-use corridor and the City owned property located at the intersection of NW 7th Avenue and Sistrunk should be targeted as a location for a commercial node. The undeveloped City owned property at 543 NW 5th Avenue is part of the NW 7th Avenue /Sistrunk Boulevard commercial node planned for mixed use development. The relocation of overhead utility lines at this location to assist with the development of this site was identified in the CRA 5-year program as a recommended capital project and incorporated into the Community Redevelopment Plan as a plan amendment on March 15, 2016.
