- **TITLE**: Discussion on Corporate Contributions to Municipal Campaigns (Commission Districts 1, 2, 3 and 4)

Pursuant to Florida Statute Chapter 106, which regulates Campaign Financing, a corporation is considered a "person" and can contribute to a candidate, political committee, or political party. Contributions are limited to \$1,000.00 for municipal campaigns. In 2002, the City of Fort Lauderdale City Commission amended Chapter 12 "Elections" of the Code of Ordinances by limiting campaign contribution and specifying entities prohibited from making contributions in municipal campaigns (Exhibit 1). According to City of Fort Lauderdale Ordinance C-02-09, limitations include:

- Contributions not to exceed \$250.00 in aggregate by any natural person.
- Prohibits any corporation, corporation not for profit, partnership, limited partnership, limited liability partnership, association cooperative, joint venture, business trust, limited liability company, professional service corporation, or sole proprietorship to contribute to any candidate to any election for the office of mayor-commission or city commissioner.
- Prohibits any contribution from any bank, financial institution, labor organization or union, political committee, political action committee, unincorporated association, or committee of continuous existence.

To identify how other municipalities manage corporate contributions across Broward County, Miami-Dade County, and Palm Beach County staff reached out to neighboring cities. Three out of the 17 identified municipalities do not allow corporate contributions. These include: 1) The City of Miami Gardens limits individual contributions to \$1,000.00, 2) The City of Hollywood limits individual contributions to \$500.00, and 3) The City of Dania Beach prohibits contributions from corporations and sets the limitation at \$250.00.
