TITLE: Resolution to Approve a Locally Funded Agreement with Florida
Department of Transportation for Riverland Road – **(Commission District
4)**

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Locally Funded Agreement with the Florida Department of Transportation (FDOT) for Riverland Road/SW 27th Avenue from SW 34th Way to SW 21st Street.

Background

On April 19, 2016, the City Commission approved a resolution in support of co-sponsoring the Broward Metropolitan Planning Organization (MPO) Transportation Investment Generating Economic Recovery (TIGER) Grant application (CAM 16-0512). The MPO was subsequently awarded an \$11.4 million TIGER grant for five roadway projects in Fort Lauderdale, Oakland Park, Pompano Beach and Lauderdale Lakes. The Fort Lauderdale project includes roadway improvements on Riverland Road/SW 27th Avenue from State Road 7 to Broward Boulevard, and NW 31st Avenue between Commercial Boulevard and McNab Road. The scope of the Riverland Road project includes two, ten-foot travel lanes, four-foot bike lanes in each direction with a one-foot buffer and improved five-foot sidewalks where they are missing. FDOT is serving as the project manager for the MPO on the implementation of these projects.

The City of Fort Lauderdale agreed to provide financial assistance to FDOT for the milling and resurfacing, pedestrian and bicycle facilities improvements of Riverland Road/SW 27th Avenue from SW 34th Way to SW 21st Street, as part of the regional Complete Streets project. The total cost for construction of the regional Complete Streets project is estimated to be \$8,076,618 with a local contribution from Fort Lauderdale of \$924,678 for construction costs. The City also previously contributed \$95,322 through a Local Funding Agreement (17-0283) for preliminary concept development on April 4, 2017. The total City contribution towards the project is \$1,020,000.

Resource Impact

There will be a fiscal impact to the City in the amount of \$924,678 for the contribution to the regional Complete Streets project during fiscal year 2019, approved at the March 5, 2019 Commission meeting through the Consolidated Budget Amendment CAM 19-0024.
