

RESOLUTION NO. 19-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A LOCALLY FUNDED AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION UNDER PROJECT FM NUMBERS 440746-5-52-01, 440746-5-62-01, AND 440746-5-62-03 FOR RIVERLAND ROAD/SOUTHWEST 27TH AVENUE FROM SOUTHWEST 34TH WAY TO SOUTHWEST 21ST STREET; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in 2016, the Broward Metropolitan Planning Organization was awarded a \$11.4 million dollar Transportation Investment Generating Economic Recovery (TIGER) grant for five roadway projects in the City of Fort Lauderdale, the City of Oakland Park, the City of Pompano Beach and the City of Lauderdale Lakes; and

WHEREAS, the City of Fort Lauderdale project includes roadway improvements on Riverland Road from State Road 7 to Broward Boulevard, and on Northwest 31st Avenue between Commercial Boulevard and McNab Road; and

WHEREAS, the Riverland Road project, includes the construction of two ten-foot travel lanes, four-foot bicycle lanes in each direction with a one-foot buffer and improved five-foot sidewalks; and

WHEREAS, the City of Fort Lauderdale and the Florida Department of Transportation wish to execute a Locally Funded Agreement for improvements to Riverland Road; and

WHEREAS, the City agrees to provide financial assistance to FDOT for the milling and resurfacing, and the construction of pedestrian and bicycle facilities improvements on Riverland Road/Southwest 27th Avenue from Southwest 34th Way to Southwest 21st Street, as part of the regional Complete Streets project; and

WHEREAS, the total cost for construction of the regional Complete Streets project is estimated to be in the amount of Eight Million Seventy-Six Thousand, Six Hundred and Eighteen Dollars (\$8,076,618.00) with a local contribution of Nine Hundred and Twenty-Four Thousand, Six Hundred and Seventy-Eight Dollars (\$924,678.00);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to execute a Locally Funded Agreement in the amount of \$924,678.00 with the Florida Department of Transportation for the roadway improvements under FM Nos. 440746-5-52-01, 440746-5-62-01, and 440746-5-62-03.

SECTION 2. The office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.
