**TITLE:** Resolution to Approve the Third Amendment to the Interlocal Agreement  
with Broward County for Community Bus Service – **(Commission Districts  
1, 2, 3 and 4)**

---

**Recommendation**

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute an Amendment to the 2014 Interlocal Agreement between the City of Fort Lauderdale and Broward County for Community Bus Service, in substantially the form attached, to amend Exhibits A, D, and F of the Interlocal Agreement.

**Background**

The City of Fort Lauderdale (City) and Broward County have an Interlocal Agreement (ILA) for Community Bus Service within the City of Fort Lauderdale that will expire on September 30, 2019 (Exhibit 1). The ILA defines the terms and conditions for the City to provide community bus services.

The Third Amendment will amend Exhibits A, D, and F of the ILA (Exhibit 2) to reflect the changes recently approved by the City Commission at the Public Hearings held on October 23, 2018, and November 6, 2018, as provided in CAMs 18-0980, 18-0640 and 18-0897, along with the proposed maps (Exhibit 3). The amendments include route revisions to the Beach Link, Las Olas Link, Downtown Link, Neighborhood Link, and NW Community Link, and approved revisions to schedules and routes due to funding restrictions. On February 25, 2019, Broward County issued a letter of approval for the revisions and additional funding reimbursements (Exhibit 4). On March 14, 2019, Broward County issued an addendum to the approval letter with a time correction (Exhibit 5).

**Resource Impact**

This action will result in a net increase in Community Bus reimbursement funding to the City.

**Strategic Connections:**

This item is a *Press Play Fort Lauderdale Strategic Plan 2018* initiative, included within the Infrastructure Cylinder of Excellence, specifically advancing:

- Goal 1: Be a pedestrian friendly, multi-modal City.
- Objective 1: Improve transportation options and reduce congestion by working with agency partners.
- Initiative 1: Strategically route and expand the Sun Trolley as an overall complement to upcoming major transportation projects.
- Initiative 6: Partner with agencies and businesses to increase commuter car-pooling and to incentivize and encourage mass transit use.
