

ASSIGNMENT OF CONTRACTS

WHEREAS, the City of Fort Lauderdale, a Florida municipality, ("City"), and CH2M Hill Engineers, Inc., a Delaware corporation authorized to transact business in the State of Florida, ("Assignor"), entered into an Agreement for Civil Engineering Services Continuing Contract dated March 7, 2017, and an Agreement for General Wastewater Consultant Professional Architectural-Engineering Services dated September 7, 2011, (collectively, "Contracts"); and

WHEREAS, Section 11.8 of each of the Contracts provides, in part, "[n]either this Agreement nor any interest herein shall be assigned, transferred, or encumbered without the written consent of the other party . . ."; and

WHEREAS, CH2M Hill Companies, Ltd., a Delaware corporation having an interest in the Agreements, merged with and into Basketball Merger Sub Inc., a Delaware corporation and wholly-owned subsidiary of Jacobs Engineering Group Inc., a Delaware corporation authorized to transact business in the State of Florida; and

WHEREAS, the Assignor and Jacobs Engineering Group Inc., a Delaware corporation authorized to transact business in the State of Florida, ("Assignee"), propose that the City consent to an assignment of the Contracts to the Assignee,



NOW, THEREFORE, Assignor and Assignee hereby agree as follows:




