Central Beach Plan Public Improvement Projects Update - (Commission District 2)

Chair Trantalis recognized Don Morris, Economic and Beach Redevelopment Area Manager - Beach Area Community Redevelopment Agency. Commissioner Glassman commented on the Board Report, noting the need for an update regarding the Las Olas Marina Expansion Project. He inquired about referenced meetings in the Board Report regarding the D.C. Alexander Park Project. Mr. Morris said that the consultant was updating the concept plan for D.C. Alexander Park to ensure the design is within the budgeted amount. The revised designs should be received later this week and will be sent to the Commission. Mr. Morris said there is a tentative meeting with the Beach Redevelopment Advisory Board (BRAB) and the Parks, Recreation and Beaches Advisory Board on May 20, 2019.

Chair Trantalis recognized Ray Cox, 101 SW 18th Avenue. Mr. Cox commented on his perspective on this item, noting the importance of safety.

Commissioner Glassman requested an update regarding when the facade lighting display on the Las Olas Garage will be lighted. Chair Trantalis recognized Tom Green, Project Manager, Central Beach Community Redevelopment Agency. Mr. Green gave an update on the facade lighting for the Las Olas Garage, stating that programming is being finalized and efforts are ongoing to determine how the

programming will be administered. Mr. Morris expounded on additional details. Comment and discussion ensued. Executive Director Chris Lagerbloom commented on the need to determine the criteria for the lighting display.
