In the last several years there has been a tremendous increase in the number of hotel/residential building developments. In the past we were told that there is a moratorium on buildings in the Central Beach Alliance. On behalf of the residents who have signed it, I present you with this petition requesting the city to deny any permits or building applications for Site Plan IV.

As a long-term resident of Fort Lauderdale and President of the Birch Crest Apartment Association I am writing today to express my sincere hope that you will act in the best interests of your constituents by arguing and, ultimately, voting in favor of the denial of the proposal currently under consideration by the Development Review Committee.

Most of my fellow residents and I have appreciated the integrity and conviction of your position in the past, and we are confident that you will act clearly to represent the dominant perspective of your constituents at this important moment and into the future.

We are writing to express our negative position to the proposed 17 story building that will ultimate provide no sun exposure, limited ocean and inter-coastal view because of this large edifice. These developers may have the finances now to fight this legislation, but with the support of forward-thinking public servants like you we can work toward balanced, long-term solutions to the land use issues. I'm opposed to this project on every level. The charm of this community is due in large part because of the diversity of the architecture. It will over burden the infrastructure of the area.

Our opposition to another large scale project is based on infrastructure limitations. We are not convinced that this community is equipped to handle the influx in demand on basic utilities, wac/sac, city services, traffic and disruption of quiet enjoyment of our residence.

A deciding factor for us during the last town hall meeting was the commitment to review all large projects in our area. Please continue to vigorously pursue the reform the city government promised the people of CBA.
