Citywide - Gardening Angel Nursery, Inc. - \$1,637,808 (estimated three-

year total) - (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, for the purchase of plants, trees and palms from Gardening Angel Nursery, Inc., in the estimated amount of \$1,637,808 and authorize the City Manager to approve one, two-year renewal option, contingent upon appropriation of funds.

Background

The Parks and Recreation Department is requesting approval to purchase plants, shrubs and groundcovers for various locations citywide.

The Procurement Services Division issued Invitation to Bid No. 12276-592 and received six bids. The bid submitted by Gardening Angel Nursery, Inc. has met all of the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder.

Resource Impact

Funds for this item in the amount of \$50,000 are available in the FY 2019. Future expenditures are contingent upon approval and appropriation of the annual budget shown below:
